



World Cup uConnect Giveaway
Promotion Schedule
17 to 28 July 2024

1. Interpretation

1.1 In this Promotion Schedule, unless the context clearly indicates a contrary intention, the following words will have the following meanings and cognate expressions will have corresponding meanings:

1.1.1 **"Customer(s)"** means any natural person having purchased, validly won, or been legally issued a ticket to attend the Polocrosse World Cup 2024;

1.1.2 **"General Promotion Terms and Conditions"** refers to the Ignition Group General Promotion Terms and Conditions to which this Promotion is subject;

1.1.3 **"ID"** refers to a valid South African Identity Document;

1.1.4 **"Organiser(s)"** means uConnect, including its affiliates;

1.1.5 **"PASA"** means the Polocrosse Association of South Africa, the official governing body and custodian of competitive polocrosse in the Republic of South Africa. PASA is the organiser and convenor of the Polocrosse World Cup 2024;

1.1.6 **"Personal Information"** shall have the same meaning as is given in section 1 of POPIA;

1.1.7 **"POPIA"** means the Protection of Personal Information Act No 4 of 2013;

1.1.8 **"Polocrosse World Cup 2024"** refers to the official competitive polocrosse sports tournament organised and hosted by PASA, scheduled to take place from 17 July 2024 to 28 July 2024 at the Durban Shongweni Club, KwaZulu-Natal (KZN); and

1.1.9 **"Promotion"** means the 'World Cup uConnect Giveaway' promotion undertaken or conducted by the Organiser as detailed in the Promotion Schedule, read with the General Promotion Terms and Conditions;

1.1.10 **"Promotion Benefit(s)"** means the benefit as set out in clause 4;

1.1.11 **"Promotion Pamphlet"** refers to the Promotion Pamphlet issued by the Organiser to Promotion Participants at the Polocrosse World Cup 2024. This Promotion Pamphlet will reflect a specific Promotion Redemption Code and the relevant QR Code;

1.1.12 **"Promotion Participant"** refers to a Customer who is inclined to participate in the Promotion by engaging with the Organiser at the Polocrosse World Cup 2024, and who interacts with the uConnect website;

1.1.13 **"Promotion Redemption Code"** refers to the unique number which will entitle a Promotion Participant to register for the Promotion upon following the QR Code on their mobile device;

1.1.14 **"Promotion Schedule"** means this schedule setting out the specific details in respect of this Promotion. Notwithstanding anything to the contrary within the Promotion Schedule, or contained in the General Promotion Terms and Conditions, in the event of a conflict between the provisions of this Promotion Schedule and the provisions of the General Promotion Terms and Conditions, the provisions of this Promotion Schedule shall take precedence;

1.1.15 **"QR Code"** shall refer to the specific quick response code, the two dimensional bar code enabling easy access to the World Cup Promotion Site through the digital camera on a Promotion Participant's smartphone or tablet;

1.1.16 **"RICA"** refers to the 'Regulation of Interception of Communications and Provision of Communication-related Information Act 70 of 2002', in terms of which the Customer shall be obliged to provide the Organiser proof of their full names, surname, ID number and residential address for purposes of activating their uConnect Mobile Sim Card or eSim;

1.1.17 **"SIM"** means Subscriber Identity Module, a smart card that stores and reconciles identification information of a subscriber's mobile device to a



particular mobile telecommunications network. Following thereon, an “eSIM” refers to an ‘Embedded SIM’, a reprogrammable chip embedded into a mobile device, as opposed to a smart card having to be inserted;

1.1.18 “uConnect” means Uconnect Mobile (Proprietary) Limited, a private company duly incorporated in accordance with the laws of the Republic of South Africa with registration number 2021/784475/07 and with registered office at Marwick Corner, 1 Lucas Drive, Hillcrest, 3610. uConnect conducts business as a mobile virtual network operator offering mobile telecommunication services to the general public of the Republic of South Africa (“uConnect Mobile”); and

1.1.19 “World Cup Promotion Site” refers to the dedicated landing page on the uConnect Mobile website, upon which Promotion Participants may register for the Promotion by entering the Promotion Redemption Code, and providing their relevant Personal Information.

1.2 Any defined terms appearing in the General Promotion Terms and Conditions shall have a consistent meaning when used in this Promotion Schedule.

2. Introduction

2.1 This Promotion is managed and administered by the Organiser.

2.2 By entering the Promotion, all Promotion Participants agree to be bound by the terms of this Promotion Schedule, read with the General Promotion Terms and Conditions.

2.3 The Promotion Schedule and the General Promotion Terms and Conditions shall be interpreted by the Organiser, and the Organiser’s decision regarding any issue will be final and binding and no correspondence will be entered into.

2.4 This Promotion shall run concurrently with the Polocrosse World Cup 2024 from 17 to 28 July 2024 (“Promotion Period”), and is a special offer available

to Customers in attendance at the Polocrosse World Cup 2024.

2.5 The Promotion deals exclusively with the provision of complimentary airtime to those Promotion Participants who are, or who become, valid subscribers of uConnect Mobile.

3. Claiming the Promotion

3.1 Purchase a Ticket to the Polocrosse World Cup 2024:

To be eligible for the Promotion, Customers must purchase a ticket to the Polocrosse World Cup 2024.

3.2 Receive a Promotion Redemption Code at the Event:

Upon engaging with the Organiser’s representatives, a Customer will be presented with a Promotion Pamphlet;

3.3 Register for the Promotion:

3.3.1 The Promotion Participant will be required to access the World Cup Promotion Site which may be done by following the QR Code on the Promotion Pamphlet;

3.3.2 If the Promotion Participant is not a subscriber to uConnect Mobile, the Promotion Participant may:

(a) with the assistance of the Organiser’s staff, activate a uConnect Mobile SIM Card; or alternatively,

(b) request activation of a uConnect Mobile eSIM;

3.3.3 The Organiser will conduct a live-check during the RICA process to determine whether the ID number that is registered against the uConnect Mobile SIM Card or eSIM does not already have the Promotion or another uConnect Mobile promotion attached to it. If that ID number already has any uConnect Mobile promotion attached to it, the Organiser will display a message to the Customer confirming this, and thereby disqualifying such Customer from participating in this Promotion.



3.3.4 The Promotion Participant will be required to register on the World Cup Promotion Site by:

- 3.3.4.1 Entering the Promotion Redemption Code;
- 3.3.4.2 Providing the necessary Personal Information, including mobile number; (“Online Sign-Up”)

3.3.5 The Promotion Participant shall be obliged to complete the Online Sign-Up within 60 (sixty) days of issue of the Promotion Redemption Code, failing which, the Promotion Redemption Code shall lapse, resulting in the Customer’s disqualification from participating in the Promotion.

(Clauses 3.3.1 to 3.3.4.2 shall be referred to collectively as the “Registration Process”)

3.3.6 The Promotion Participant shall be eligible for the Promotion Benefit from the date of completion of the Registration Process (“Promotion Activation Date”).

4. The Promotion Benefit

4.1.1 The Promotion Participant will be entitled to receive, through their uConnect Mobile SIM Card or eSIM, R50 (Fifty Rand) worth of complimentary airtime per month (“Monthly Allocation”), for a period of 12 (twelve) months, commencing as from the Promotion Activation Date (“Total Allocation Period”).

4.1.2 The first Monthly Allocation shall be credited to the Promotion Participant’s uConnect Mobile SIM Card or eSIM on the Promotion Activation Date, and thereafter, each Monthly Allocation will be credited on the corresponding day of each successive month.

5. Promotion-Specific Terms and Conditions

5.1.1 Eligibility

5.1.1.1 The Promotion is only open to South African citizens with a valid Identity Document (ID). Only an ID number will suffice for purposes of the RICA process.

5.1.1.2 Under no circumstances will a passport number be acceptable for purposes of the Promotion.

5.1.1.3 The Promotion is open to Customers who are employees of uConnect and/or the Organiser’s affiliates.

5.1.1.4 **As stated at clause 3.3.3 above, if the Customer or a Promotion Participant is already registered for any other promotion offered by uConnect Mobile, the Customer or Promotion Participant shall be precluded from registering for this Promotion.**

5.1.2 Promotion Restriction

The Organiser will issue a maximum of 6000 (Six Thousand) Promotion Redemption Codes per day during the Promotion Period. The Promotion is therefore only available to the first 6000 (Six Thousand) eligible Customers that successfully complete the Registration Process at clause 3 above. This Promotion will have an upper limit capped at 72 000 (Seventy-Two Thousand) Promotion Participants during the Promotion Period.

5.1.3 Monthly Allocation Validity

5.1.3.1 Each Monthly Allocation expires within 30 (thirty) days from the date upon which it is provisioned to the Promotion Participant.

5.1.3.2 Each Monthly Allocation shall, under no circumstances, roll-over into the next month or accumulate each month during the Total Allocation Period.

5.1.4 Promotion Redemption Code and Registration Process

5.1.4.1 Each Promotion Participant will be entitled to use the Promotion Redemption Code only once upon attending the Polocrosse World Cup event.

5.1.4.2 Once a Promotion Participant has been issued with a uConnect Mobile SIM Card or a uConnect Mobile eSIM, and has followed the Registration Process entitling them to the Promotion



Benefit, such Promotion Participant shall not be permitted to participate in the Promotion again.

uConnect mobile number, with such notification advising of the month from which the Promotion Benefits will cease.

5.1.4.3 uConnect reserves the right to refuse a Customer or Promotion Participant from registering for the Promotion more than once.

5.1.4.4 If it is found that a Promotion Participant has been benefitting from the Promotion by executing the Registration Process more than once, the Organiser reserves the right to render each Registration Process void *ab initio*, and reserves the right to reclaim all Promotion Benefits dispensed in their entirety.

5.1.4.5 The provision of the uConnect Mobile SIM Card and/or eSIM, and the Promotion Benefits, shall at all times be subject to the uConnect Mobile Subscriber Terms and Conditions available at: <https://uconnect.co.za/wp-content/uploads/uConnect-Subscriber-Terms-and-Conditions-30.11.2023.pdf> .

5.1.5 **Non-Transferable:**

5.1.5.1 The Promotion Redemption Code and the Promotion Benefits are strictly non-transferable.

5.1.5.2 Under no circumstances will the Organiser be obliged to transfer the value of any Promotion Benefits to a SIM Card or eSIM that is not linked to uConnect Mobile.

5.1.5.3 Under no circumstances will the Promotion Benefits be redeemable for cash.

5.1.6 **Termination of Promotion or Changes to Promotion Benefits**

5.1.6.1 The Organiser reserves the right to vary or change the terms of the Promotion at any time during the Total Allocation Period.

5.1.6.2 The Organiser reserves the right to summarily terminate the Promotion at any time, at its sole discretion, and without any penalty, during the Total Allocation Period by issuing the Promotion Participant with 14 (fourteen) days SMS notification to that effect via their
